

# The SACSCOC Reaffirmation of Accreditation Process

### Components

#### > Compliance Certification

- > 15 Core Requirements basic, broad-based, foundational requirements that an institution must meet to be accredited.
- > 58 Comprehensive Standards more specific to the operations of the institution, represent good practice in higher education, and establish a level of accomplishment expected of all institutions.
- > 9 Federal Requirements mandates that the Commission review an institution in accordance with criteria outlined in federal regulations developed by the U.S. Department of Education.

#### > Quality Enhancement Plan Proposal



## **Examples**

**CR-2.5** The institution engages in ongoing, integrated, and institution-wide research-based planning and evaluation processes that (1) incorporate a systematic review of institutional mission, goals, and outcomes; (2) result in continuing improvement in institutional quality; and (3) demonstrate the institution is effectively accomplishing its mission. (Institutional Effectiveness)

**CS**-3.3.1 The institution identifies expected outcomes, assesses the extent to which it achieves these outcomes, and provides evidence of improvement based on analysis of the results in each of the following areas: (Institutional Effectiveness)

- 3.3.1.1 educational programs, to include student learning outcomes
- 3.3.1.2 administrative support services
- 3.3.1.3 academic and student support services
- 3.3.1.4 research within its mission, if appropriate
- 3.3.1.5 community/public service within its mission, if appropriate



# **Steps in the Process**

- > Compliance Certification submitted as written report
- > Report reviewed offsite by SACSCOC evaluators
- > Offsite evaluators compile report listing any questions or remaining compliance issues
  - > Report forwarded to institution and on-site team for follow-up
- > Institution may prepare a Focused Report in writing addressing the issues found by offsite team
- > QEP Proposal submitted
- > On-site visit by (different) SACSCOC evaluation team
