

NUR 212 Health System Concepts

COURSE DESCRIPTION:

Prerequisites: NUR 111, Nur 112, Nur 114, BIO 168, BIO 169, BIO 271, PSY 150, PSY 241, ENG 111, Must be enrolled in Associate Degree Nursing Program

Corequisites: None

This course was designed to further develop the concepts within the three domains of the individual, healthcare, and nursing. Emphasis is placed on the concepts of grief/loss, violence, health-wellness-illness, collaboration, managing care, safety, advocacy, legal issues, health policy, healthcare systems, ethics, accountability, and evidence-based practice. *Upon completion, students should be able to provide safe nursing care incorporating the concepts identified in the course.*
