



2025-2026 Unusual Enrollment History Appeal Form

The U.S. Department of Education has selected your Free Application for Federal Student Aid (FAFSA) for review due to your unusual enrollment history. An unusual enrollment history is defined as having attended and received Federal Pell Grant or Direct Loan funds from multiple colleges or universities during the review periods of 2021-2022, 2022-2023, 2023-2024, and 2024-2025. Before processing your federal aid request, Durham Technical Community College is required to evaluate your enrollment history to ascertain whether you are earning academic credit at all institutions listed during the specified years.

In conducting this evaluation, the Financial Aid Office will refer to the National Student Loan Data System (NSLDS) to gather a comprehensive record of the Federal Pell Grants and Direct Loans you have received, along with the corresponding institutions that granted these funds. Additionally, the Financial Aid Office is obligated to review your academic transcript(s), indicating dates of attendance and credits earned for all institutions listed. **It is important to note that if you waive the submission of transcripts for any institution(s) during the admissions process, those transcripts remain mandatory for this review.**
